Objectives

- 1) To set out the general principles and practices of mutual cooperation in the field of Placement & Training activities.
- 2) To facilitate intellectual development on both campuses.

Scope of Operation

- 1) Activities in this MoU will be carried out for students of both the institutes.
- 2) Facilitate the exchange of information on their respective educational systems and policies to assist in ongoing education reform.
- 3) Facilitate and provide inputs in Certificate and Enrichment Programs.
- 4) The professional development of, students through regular training programs.
- 5) Training of students for professional course/s entrance examination aptitude development guidance, etc.

Implementation

Both the parties to MoU will establish a joint committee for policy dialogue to regularly exchange information and experience on education challenges and reforms, and to identify priorities and opportunities for bilateral cooperation in the field of Placement & Training activities.

- 2) Respective institutions will bear all the expenses incurred while sending their students to the host institutions during the exchange program. Further this can be relaxed as per the dialog between the institutions on mutual consent.


Dispute Settlement



Tenure of MoU:

- 1) This MoU will come into effect on the date of signature.
- 2) This MoU will remain in effect for an initial period of one (1) (ACADEMIC YEAR 2021 - 2022) year and will be extended for successive periods of one (1) year, unless either side notifies the other side, in writing, of its intention to terminate this MoU at least three (3) months before the expiry date of the relevant period.
