This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as the "MoU") is entered into on 12/10/2022.

BETWEEN

Department of Physics, B. L. D. E. Association's S. B. Arts & K. C. P Science College, Bangaramma Sajjan Campus, BLDE Road, Vijayapura - 586 103. Here in referred as the Party of the First part.

AND

Department of Physics, J. S. S. Arts, Science and Commerce College, Gokak - 591 307. Here in referred as the Party of the Second part.

WHEREAS

Based on a foundation of trust for the mutual benefit and development of two Institutes & promotion of national understanding and goodwill, Department of Physics, BLDEA'S S. B. Arts & K. C. P. Science College, Vijayapur (Party-1) & Department of Physics, J S S Arts, Science and Commerce College, Gokak - 591 307 (Party-2) agreed as follows:

Background:

Department of Physics, BLDEA'S S. B. Arts & K. C. P. Science College, Vijayapur (Party-1) & Department of Physics, J. S. S. Arts, Science and Commerce College, Gokak - 591 307 (Party-2) for the purpose of co-operation through educational, research &

academic exchange, hereby affirm their intent to promote such co-operation activities as will be of mutual benefit for their respective institutions.

Scope of Co-operation & Activities:

1. Development of mutually beneficial academic programmes & Courses.
2. Coordination of academic Staff mobility for the purpose of teaching, research & training.
3. Coordination of UG (B.Sc. Physics) and PG students (M.Sc. Physics) mobility programmes for study and research.
4. Sharing of research facilities on mutually agreed terms.
5. Coordination of academic activities such as joint research, joint supervision of UG, PG and doctoral program, joint publication(s), origination of joint QIP (Quality Improvement Programme) and training programmes.
6. Other such activities as considered by the parties to be of mutual benefit towards Workshops, Seminars, Educational & Research Programme.

Management of Co-operation:

1. The implementation of exchange based on the MoU shall be separately negotiated & determined by both institutes (Party-1 & Party-2).
2. Nothing shall diminish the full autonomy of either institute (Party-1 & Party-2) nor will any constraint or financial obligations be imposed by either upon the other in carrying out MoU.

The Parties are desirous of entering into this Memorandum of Understanding (MoU) as per the terms and conditions set out here under.

NOW IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. The MoU will be valid for a period by one year from the effective date. Thereafter, renewal of the MoU will be subject to the written agreement between the parties.
2. The MoU is subject to revision by Mutual written agreement.
3. It is also understand that, either party may terminate the MoU for any reason & that any time upon thirty (30) days prior written notice to the other party. Although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties.
4. The MoU is effective when representatives of both parties have signed & dated the document (Effective date).

ARBITRATION


1. In the event of any dispute or difference between the parties arising out of or in connection with this MoU such dispute or differences shall be settled amicably or else referred to the sole arbitration of head of departments.
2. Arbitration proceedings shall be governed under Arbitration and conciliation Act 1996 and the venue of such Arbitration proceedings shall be at either of the institution as applicable.

The decision of the Head of the both institution will be final.

TERMINATION

Though the initial period of campus license issued is for a period of two years however in-case of any changes in the program and its structure whether partial or in total, the same would be communicated at least 45 days in advance to the either institution and it would be solely their voluntary decision whether to continue for the program. The parties have executed this MoU by their duly authorized representatives as on the above-mentioned date.


